Dear Campers:

Welcome to Feinberg Park! We are pleased that you have chosen our park for your outdoor experience. By observing these simple guidelines, you can help us to make your stay at the park a pleasant and enjoyable experience.

- *Campsite rent must be paid in full prior to set up.
- *Electric fees are in addition to lot rent. Each site will have its own meter box. Electric meters will be read every thirty (30) days for seasonal campers. Payment must be made within seven (7) days of billing. Daily, weekly, and monthly campers will be billed before leaving the park; payment is due at that time.
- *Each campsite can only be rented to a maximum of two (2) adults and their dependents, children. You must be at least twenty-five (25) years of age to rent a campsite. Each site is limited to one (1) tent and one (1) camper.
- *The park closes at 9:00 p.m., the inside gates will be locked at that time. The roadside gates will be locked after the snack bar closes.
- *Campers will be responsible for the conduct of anyone staying at or visiting their campsite. Visitors will be charged \$2.00 per day, per vehicle, and are obligated to observe all rules of the campground. A day pass for visitors is only valid until the park closes at 9 p.m. Visitors will be expected to leave before the gates are locked. Overnight guests will be charged \$5.00 per person and must register at the office.
- *Please note that the speed limit throughout the park is **5 MPH** and will be enforced.
- *The public phone at the park is provided for the convenience of the campers; please be courteous of other users. Parents are responsible for ensuring that their children do not abuse the phone.
- *Campers will be responsible for keeping their site neat and orderly, this includes the sides & back of campers and disposing of trash properly. All plastic, Styrofoam, and garbage must be put into the dumpster located behind the showers. Toys, bicycles, etc. must be picked up and stored neatly each night. Please note one dumpster is for

recyclables & one is for trash. Please use the appropriate dumpster.
Do not leave paper or other trash in fire pits when leaving the park.
It draws animals & is dragged through the park.

*No firewood will be permitted in the park unless it is cut up in firewood lengths and stacked neatly on site. Fire codes require that pallets must be broken up before they are brought into the park. No more than 2 face cords of wood can be stacked on a lot at any one time. Fires are restricted to the fireplace provided on site. No bonfires or burning barrels are permitted.

*Chainsaws, other than those used by town employees, are not permitted in the park.

*If you plan to bring your pet to camp, please be prepared to show proof of rabies vaccination upon entering the park. Pets are not allowed in the picnic area. Pets must be confined to the owner's campsite at all times. Pet owners are responsible for cleaning up after their animals. Unattended dogs are not permitted anywhere in the park. If you leave the park, you must take your dog with you. If you walk your dog through the park, you are required to pick up its waste.

*No disorderly conduct or destruction of park property will be tolerated, including graffiti. Violators will be asked to leave.

*Bicycle riders under the age of 15 must wear a helmet while riding in the park. Bike riding after dark is not permitted. Use of roller blades, bicycles, and skateboards, are not permitted inside the basketball or tennis courts.

*All firearms (including paintball and "BB" guns), fireworks, archery equipment, and Slingshots are not permitted in the park.

*All children and teens must be in their lot by 10:00 p.m., unless accompanied by their parents. Quiet time is from 11:00 p.m. to 8:00 a.m. Excessive noise will not be tolerated.

*Unlicensed motor vehicles are not permitted on park property. This includes all cars, trucks, 4-wheelers, dirt bikes and ATV's. ATV's of any kind are not to be driven in the park. Storage of boats, motor vehicles or trailers is not permitted.

*No additions of any kind, unless original to camp, or commercially made for the camper are permitted. Factory made screen houses are allowed. Decks & porches must be removable & approved by management.

*Children under the age of 7 must have adult supervision on playgrounds.

*Please note when you decided to stop camping @ the park you are responsible for leaving the park empty of debris. Anything left will be hauled away and you will be billed for the charges.
